

APPLICATION FOR A CEASE AND DESIST ORDER  
IN A U. S. FEDERAL COURT

We hereby file an application for a cease and desist injunction against the authors and participants of

[www.crackpotwatch.wordpress.com](http://www.crackpotwatch.wordpress.com)

and its carrier, Wordpress Inc. of California, together with Ioan Richard of 23 Mountain Road, Craig Cefn Parc, Swansea SA6 5RA, Wales. Wordpress has been notified of our intention and is fully aware of the felonies and torts committed by the above site, several thousand offences over six years of violations listed below. From information on [www.statshow.com](http://www.statshow.com) this site is not ranked anywhere, its Alexa rank is unavailable because it has almost no traffic. It has no pages indexed because it has been banned in the past, or suffered a penalty. It is known that in 2012 it was banned from Tesco (entry on my [www.aias.us](http://www.aias.us) blog for 2012). Yet Wordpress continues to host it and to date has repeatedly refused to remove it. It was launched on March 3<sup>rd</sup> 2000. Its IP number is 192.0.78.12, 26th Street, San Francisco, California. This is the Wordpress address. Its owner is Wordpress. Its ICN Registrar is MARKMONITOR INC. Since the crackpot site has already been banned or been served a penalty, there is de facto evidence to have it removed entirely by court order with a request for damages.

In contrast my [www.aias.us](http://www.aias.us) site and blog, which crackpot has harassed for six years, is in the top 0.4% of all sites in the world on [www.statshow.com](http://www.statshow.com), and its traffic has increased by 256% in the last three months.

On [www.SEMrush.com](http://www.SEMrush.com) it is seen that crackpot gets virtually no traffic at all, and this is verified by my referral analysis for [www.aias.us](http://www.aias.us). On [www.prchecker.info](http://www.prchecker.info) the crackpot site gets zero out of ten. Crackpot has apparently been read in only four countries, Britain, US, Italy and Luxembourg. All visits from Italy and Luxembourg have stopped in the past two or three years. The main author uses British English, and is almost certainly English judging by his language structure and spelling.

One corresponding member of crackpot is known: Ioan Richard of 23 Mountain Road, Craig Cefn Parc, Swansea SA6 5RA He identified himself in Craigcefnparc News 19 on May 11<sup>th</sup> 2017 on [www.crackpotwatch.wordpress.com](http://www.crackpotwatch.wordpress.com). He is a retired County Councillor and the fact that he is concerned with a blog that has committed many felonies is of grave public concern. He has also identified with ethnic hate crime against Wales, the language and People. Richard continues to harass. The Local Authority Ombudsman advises that Richard's conduct is a matter for the police. He formerly operated under a pseudonym "Former Coal Miner". So the Court Order could be served on Wordpress and Ioan Richard, the intention is to serve it on all parties associated with this hate blog. These two parties have been identified.

We request the Court to:

- 1) Order the removal of the entire blog;
- 2) Prohibit its reappearance hosted by another carrier;
- 3) To order removal of all caches under right to be forgotten legislation;
- 4) Award punitive damages commensurate with several thousand offences;
- 5) Fine the Wordpress Directors and order that they reveal the identities of all participants of the blog.

Under the law of England and Wales, the offences committed are as follows, with de facto evidence taken from the blog. There are closely equivalent laws in the United States.

I) The Criminal Justice and Courts Act 2015 makes it a crime to send grossly offensive material, convey a threat, disseminate false information, and so forth with the purpose of causing distress and anxiety. This is punishable by up to two years in prison and obliges a convicted criminal to cover the cost of prosecution. Heavy fines may be imposed. Justice Minister Grayling has described such behaviour as “awful crimes”. The following is a small sample of de facto evidence for this crime, taken from the troll site.

### Sample of Evidence

- 1) July 20<sup>th</sup> 2015: The eminent scholar Stephen Crothers described as an irrelevant little clown.
- 2) July 24<sup>th</sup> 2015: The U. S. broadcaster Jeff Rense described as a rabid anti semite.
- 3) July 23<sup>rd</sup> 2015: Welsh is described as a useless language.
- 4) Aug. 2<sup>nd</sup> 2015: I am described as a monster.
- 5) Aug. 1<sup>st</sup> 2015: I am named “Moron” and this is repeated often in the Craigeefnparc section of the hate blog.
- 6) Aug. 1<sup>st</sup> 2015: Hitler would have been pleased with my colleagues.
- 7) Aug 27<sup>th</sup> 2015: A false accusation about a cancer therapy.
- 8) Aug 25<sup>th</sup> 2015: Dr. Anthony John Williams described as a fraud. Dr. Judy Wood described as a whore.
- 9) Aug. 17<sup>th</sup> 2015, one of many false accusations of lying. In general, many wildly pejorative terms such as crackpot, crank, loonie, applied indiscriminately to distinguished people.
- 10) Aug. 9<sup>th</sup> 2015, Bernhard Foltz described as a member of the S. S.
- 11) Aug. 9<sup>th</sup> 2015 indiscriminate false accusations about selling useless devices.
- 12) Sept 11<sup>th</sup> 2015 Accused of despoiling a U. K. Beauty spot when I referred to interest from the University of Bath.
- 13) Sept 12<sup>th</sup> 2015: The famous inventor Grindell Mathews described as an isolated crank.
- 14) Sept 11<sup>th</sup> 2015: The eminent scholar and UPITEC President, Dr Horst Eckardt, described as a member of the S. S. (Siemens Stain).
- 15) Sept 7<sup>th</sup> 2015: I am described as an “unspeakable clown” and the award winning teacher and author Kerry Pendergast as Penderghastly.
- 16) Sept. 7<sup>th</sup> 2015: The U.S. author and lecturer Lar Felker described as an “Irish Joke” and the famous physicist and Member of the Legion d’Honneur, Jean-Pierre Vigier as “demented”. I am told not to mention their death threats. So they are aware that these are criminal offences.
- 17) Sept. 19<sup>th</sup> 2015: I am described as a screwball and plagiarist.
- 18) The Chair of the Vigier Conferences, Dr Richard Amoroso, is described as Yes Man Crank, because he had mentioned my several nominations for a Nobel Prize.
- 19) Sept 12<sup>th</sup> 2015: The inventor Searle described as a thief. I have never met Dr. Searle, or ever corresponded with him.
- 20) The distinguished Japanese author and inventor Osamu Ide described as a crank, apparently for patenting a revolutionary circuit design.
- 21) May 2017: There are many wildly pejorative comments, for example I am described as a disgrace to Wales, a national disgrace, and a Quisling.
- 22) April 29<sup>th</sup> 2017, the large readership of “Principles of ECE” is described as in need of psychiatric help.
- 23) May 6<sup>th</sup> 2017: It is asked how can I be descended from a Morgan if my name is Evans.

This comment shows that the main author of the hate blog has lost touch with reality.  
24) May 11<sup>th</sup> 2017, the eminent editor, Prof. Emeritus Alwyn van der Merwe, described as Alwyn van der Merde, which is French for Alwyn from the shit.  
25) May 12<sup>th</sup> 2017: The famous Sir Fred Hoyle is described as a crackpot.

All of these are wildly offensive, pejorative and defamatory comments aimed at anyone with whom I correspond. So they are aimed at myself. Other AIAS Fellows such as Michael Jackson and Robert Cheshire are repeatedly and severely defamed.

II) The Protection from Harassment Act 1997, Sections 2 and 4 makes cyberbullying and making threats crime punishable by fines and or imprisonment. The following is a small sample of de facto evidence from the blog for cyberbullying and making threats, including multiple death threats. These threats have been going on for about six years. The following is a small sample of direct death threat from the early stages of the blog

Evidence

- 1) "We look forward to the day when shooting crackpots will be excused".
- 2) "Whatever, a .45 would have been very comforting".
- 3) "But then, we like Caligula wish that all the hundreds of crackpots had but one neck".
- 4) "You may as well hang together, as you will certainly hang separately".
- 5) "Death of a Welsh crackpot".
- 6) On April 23<sup>rd</sup> 2017, another death threat, it is hoped that I have enough rope to hang myself over Easter, a strange allusion to Judas Iscariot.
- 7) In May 2017 another death threat, about being thrown over the Reichenbach falls.

The entire blog from 2011 onwards is a systematic course of severe harassment with meany death threats. The entire blog is a type of cyberbullying.

III) The Crime and Disorder Act 1998 prohibits ethnic prejudice, in this case prejudice against a person who speaks the Welsh language and is of Welsh descent. For example my given name "Myron" is mockingly and offensively distorted as "Ron" and "Moron" many times. Each offence is punishable in law, and each offender is punishable by law.

Evidence

There are many allusions to ethnic prejudice against the Welsh language and People, this is ancient ethnic prejudice which is a serious hate crime. There have been many hate crimes, and one hate letter investigated by the South Wales Police Hate Crime Unit. Some of the evidence is abstracted above.

IV) The Criminal Justice Act 2003 prohibits disability prejudice. The blog many times falsely accuses me of mental illness, and mocks the alleged illness in an attempt to give the impression of incompetence. The title "crackpotwatch" is a false accusation of mental illness.

Evidence

Some of the evidence is collected above, there are many allusions to and false accusations of mental illness, breakdown and so on. In August 2016 I was found by a British Government expert to be in perfect health, during a P. I. P. (personal independence payment)

examination in Swansea. The entire evidence for my perfect health can be forwarded to the Court if the Judge so rules.

V) The Offences Against the Person Act 1861 makes it a serious offence to make a death threat. The blog contains many death threats. The carrier Wordpress has been made fully aware of these death threats and is an accessory to making death threats.

Evidence

A small sample of death threats is appended above. The effect of making so many threats has been to instigate local violence, so these threats have for example resulted in property damage to my car, and verbal common assaults by near neighbours.

VI) The Malicious Communications Act 1988 prohibits trolling. Recent legislation makes trolling a felony punishable by up to two years in prison.

Evidence

The entire blog is a sample of repeated trolling over a span of six years.

Summary of Evidence

The blog contains multiple death threats, threats of grievous bodily harm and threats of property damage. The threats of property damage has been carried out and a police investigation started. There is CCTV footage available of a suspect and this can be given in evidence to the Federal Court. Last August I was found to be in perfect psychological and physical health by a British Government medical expert and this report can be given in evidence to the U. S. Federal Court. In 2010 I was found to be in perfect psychological health by Clydach Health Centre, Swansea, and this letter can also be placed in evidence before a U. S. Federal Court.

The blog makes gross distortions of my work and career. I was appointed a Civil List Pensioner directly by Queen Elizabeth II and Parliament in 2005, a life appointment in honour of my achievements in science. I was raised to Armiger in 2008 and awarded a coat of arms to mark the award of the Civil List Pension, and included in “Burke’s Peerage and Gentry” in 2012. In the modern British system these are all high honours. The blog contains a huge amount of distortion of these easily verifiable facts available in the public domain. Accordingly, punitive damages are sought against Wordpress and all the participants of the blog, authors and participants in group trolling. My international colleagues have been similarly abused and each is entitled to sue separately or in a class action.

The policy of the Crown Prosecution Service of the British Government is to prosecute these serious crimes robustly.
